Emergency Ordinance 20-20

A non-code ordinance of the City of Angoon, Alaska

AN EMERGENCY ORDINANCE OF THE CITY OF ANGOON AUTHORIZING A LOCAL STIMULUS PACKAGE FOR ANGOON RESIDENTS

WHEREAS, on March 23, 2020, the City of Angoon declared a local emergency in response to COVID-19; and

WHEREAS, in response to the COVID-19 Emergency, the Angoon Community Association issued an energy credit to all elders in Angoon; and

WHEREAS, the City Council wishes to provide relief to the residents of Angoon in response to the economic hardships experienced by all residents as a direct result of the COVID19 Pandemic.

THEREFORE BE IT ENACTED BY THE CITY COUNCIL OF ANGOON ALASKA:

1. That the City of Angoon shall issue a grocery credit in the amount of \$50 for each eligible child and adult in Angoon. Currently in Angoon there are an estimated 359 total residents. The estimated total cost of this credit will be \$17,950.00.

2. That the City of Angoon shall issue an energy credit in the amount of \$100 to each occupied household in Angoon. This credit can only be applied to an electric bill, to the purchase of home heating fuel, or to the purchase of propane. Currently in Angoon there are an estimated 132 occupied households. The total cost of this credit will be \$13,200.

3. The total cost of this expenditure will be \$31,150. To allow for minor resident count discrepancies, the total amount for this stimulus package shall not exceed \$32,000.

4. The initial expense shall be paid out of the City of Angoon General Fund and will be reimbursed by incoming grant funding through the federal CARES Act in response to COVID19

A RESOLUTION OF THE CITY OF ANGOON REQUESTING THE ALASKA DEPARTMENT OF FISH AND GAME TO AUTHORIZE A TEMPORARY LIFT OF ANY FISHING OR HUNTING RESTRICTIONS IN RESPONSE TO COVID19

WHEREAS, on March 23, 2020, the City of Angoon declared a local emergency in response to COVID-19; and

WHEREAS, Angoon residents are and have been for thousands of years, heavily reliant on fishing and hunting to provide sustenance for its people; and

WHEREAS, a reduction in transportation services in response to COVID19 has decreased the availability of purchasable foods in Angoon; and

WHEREAS, a drastic reduction in transportation services in response to COVID19 has increased the cost of living in Angoon to unprecedented levels; and

WHEREAS, Angoon residents can provide for themselves through subsistence harvesting of fish and game, and wish to be allowed to subsist without fear of any state legal actions against them.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF ANGOON ALASKA:

1. That this resolution serves as a formal request to Governor Dunleavy and the Alaska Department of Fish and Game to temporarily remove legal restrictions on hunting and fishing in response to COVID19, to allow Angoon residents the option to be self-reliant by harvesting fish and game for subsistence purposes without fear of legal actions from the state.

A RESOLUTION ESTABLISHING ANGOON COVID19 RULE 4 REGARDING SELF-QUARANTINE REQUIREMENTS AND RESIDENT/NON-RESIDENT TRAVEL RESTRICTIONS AND REQUIREMENTS

WHEREAS, COVID-19 is a respiratory disease that can result in serious illness or death and is caused by the SARS-Cov-2 virus ("virus"), a new strain of the corona virus that has not been previously identified in humans and is easily transmittable person to person; and

WHEREAS, on March 11, 2020, the World Health Organization ("WHO") declared the virus a pandemic; Alaska Governor Dunleavy issued a declaration of public health disaster emergency in response to the anticipated outbreak of COVID-19 in Alaska; and on March 13, 2020, President Donald J. Trump declared a national emergency in response to the virus pandemic; and

WHEREAS, on March 23, 2020, the City of Angoon declared a local emergency in response to COVID-19; and

WHEREAS, on March 26, 2020, the City of Angoon passed Resolution 20-17B, establishing the nonresident travel ban that went into effect on April 1, 2020; and

WHEREAS, on March 28, 2020, the State of Alaska established the "Alaska Small Community Emergency Travel Order", which allowed for certain rural communities to set stricter travel bans than the state; and

WHEREAS, on April 9, 2020, the State of Alaska amended the "Alaska Small Community Emergency Travel Order", changing what certain rural communities were able to restrict; and

WHEREAS, this resolution will bring the City of Angoon into compliance with the Alaska Small Community Emergency Travel Order and the Alaska Essential Services and Critical Workforce Infrastructure Order; and

WHEREAS, during the 1918 Spanish Flu Pandemic, the Village of Shishmaref was successful in preventing any deaths in their community by totally locking down their village to prevent all entry; and

WHEREAS, this resolution shall have the same authority as an Emergency Order issued by the Mayor pursuant to his authority under AMC 2.66.230.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF ANGOON ALASKA:

TRAVEL

- That all incoming non-resident travel is banned, except for Essential Services and Critical Workforce Infrastructure as defined in Section II of the "Alaska Essential Services and Critical Workforce Infrastructure Order" and exemptions as provided in section 2 of this resolution.
- 2. That exemptions to non-resident travel restrictions are as follows:
 - A. Emergency First Responders.

- B. Law Enforcement acting within their official duties.
- C. Office of Children's Services personnel responding to reports of child abuse and neglect and insuring child safety.
- **D.** Essential Governmental Services personnel needed to ensure the continuing operations of government agencies including to provide for the health, safety, and welfare of the public.
- E. Persons engaged in subsistence fishing and in the fishing industry including the fisherman, processors, guides, and transporters of the fish as well of those under contract with the fisherman, processors, guides, and transporters for provisioning.
- F. Residents returning to the resident's home from outside of Angoon that show no signs or symptoms of COVID-19
- 3. That a resident is defined as anyone who currently physically lives in Angoon and has maintained a physical presence for a minimum of 10 of the last 12 months.
- 4. That all resident travel is banned to and from Angoon except for essential travel to include buying, selling, or delivering groceries and home goods; obtaining fuel for vehicles or residential needs; transporting family members for out-of-home care, essential health needs, or for purposes of child custody exchanges; receiving essential health care; providing essential health care to a family member; obtaining other important goods; and engaging in subsistence activities.

SELF-QUARANTINE

- 5. That upon arrival to Angoon, all resident travelers are required to immediately go to their home and remain there for a mandatory 14-day self-quarantine. The only exemption to this self-quarantine requirement is for resident miners only if they return to Angoon on a direct flight from the mine.
- 6. That upon arrival, all exempted non-resident travelers shall immediately report to their place of work or business and remain there for a mandatory 14-day self-quarantine.
- 7. That all travelers, upon competing the mandatory 14-day self-quarantine, are required to comply with all shelter in place and hunker down mandates as established by the State of Alaska and the City of Angoon.

SECTION 2-E BUSINESS AND PERSONNEL REQUIREMENTS

8. That all fishing businesses exempted from the travel ban pursuant to section 2-E submit to the City of Angoon a copy of the travel plan or protocol that the business submitted to the Department of Commerce, Community and Economic Development pursuant to State of Alaska Health Mandate 010 or 012 with the understanding that the City of Angoon will ensure enforcement of that plan.

A RESOLUTION ESTABLISHING ANGOON COVID19 RULE 4 REGARDING SELF-QUARANTINE REQUIREMENTS AND RESIDENT/NON-RESIDENT TRAVEL RESTRICTIONS AND REQUIREMENTS

- **9.** That all fishing businesses exempted from the travel ban pursuant to section 2-E are required to provide their plan for how they intend to quarantine personnel who develop a fever, cough or shortness of breath (collectively "Symptoms") while in the Angoon;
- **10.** That all fishing businesses exempted from the travel ban pursuant to section 2-E are required to provide their plan for how they intend to provide their own medical evacuation;
- 11. That all fishing businesses and their personnel exempted from the travel ban pursuant to section 2-E are required to conduct screenings for Symptoms a minimum of 48 hours ("Health Screening") prior to traveling to Angoon and that any personnel who manifest any Symptoms during this screening are restricted from traveling to Angoon.
- **12.** That all fishing businesses and their personnel exempted from the travel ban pursuant to section 2-E are required upon arrival in Angoon to receive a Health Screening, and any personnel who manifest Symptoms are required to leave Angoon immediately.

ENFORCEMENT

- **13.** That any violation of any terms of this Resolution be punishable by a fine of \$500 and a mandatory court appearance as provided by Emergency Ordinance 20-15 passed on March 28, 2020.
- 14. That a City Code Compliance Officer will be issuing citations for the first mandate violation and will refer continued violations to the Angoon VPSO to have additional state criminal charges filed.

OTHER

- 15. That this resolution may also be referred to as "Angoon COVID-19 Rule 4 Travel and Self-Quarantine."
- 16. That Resolution 20-14 be rescinded and replaced by this Resolution.
- 17. That Resolution 20-17B be rescinded and replaced by this Resolution.
- **18.** That this resolution be effective immediately and shall remain in effect until May 1, 2020, or until rescinded by the City Council, whichever is sooner.
- PASSED and APPROVED by the Angoon City Council this 15th day of April 2020.
